Congratulations and Welcome to the HavaHug Family! We know from experience that this is a wonderful and exciting time for your family! Adding a Havanese puppy to your life means increasing the amount of joy, love and adventure in your years to come! Your HavaHug puppy is guaranteed to be an AKC registered purebred Havanese. As the breeder, I will give you, the buyer, your pup's AKC registration papers upon receiving this signed contract and full & final payment.

### Deposits

A \$500 deposit will hold the puppy of your choice and this deposit is nonrefundable. Non-refundable Wait List Reservations are also available through this deposit, allowing your pick from on an upcoming litter, based on the order in which your deposit was received. Holds and Wait list reservations are made available at the discretion of the breeder. Should you not see the puppy that you are hoping for, within the litter you have been wait listed for, you may move your deposit ahead to the next available opening, for 1 full year or at least 1 additional litter. After which time, your deposit will then become void.

### Full Payment

**FULL PAYMENT IS DUE BY THE TIME YOUR PUPPY TURNS 6 WEEK OF AGE.. REGARDLESS OF YOUR PICK UP DATE. If full payment is not received by the time**

**your puppy turns 6 weeks old, you will forfeit your deposit/hold on that puppy and the puppy may be re-listed.**

**\*\* If you opt to take advantage of the grace period, full payment is still due by the time your puppy turns 6 weeks old.**

**Payment may be made by cashiers check, money order, PayPal, Venmo or the Cash Card App. Purchaser is responsible for any associated fees.**

**Please note: \*\* Depending on how your payment is made, PayPal may charge an additional 2.9% fee for those paying USD and 3.9% for those paying CAD.**

\*\* If your puppy is already passed the age of 8 weeks when you place your deposit, full payment is due within 1 week of your deposit, at the discretion of the breeder.

Grace Period: Holding Puppies Beyond 8 Weeks

Our puppies are typically ready to go home to their furever families at 8 weeks of age. Please be prepared to pick up your puppy, or have your puppy flown home, at this time. Breeder will notify Buyer if it is determined that a particular puppy needs more time. In this case, no boarding fee will be assessed for this additional time with the breeder.

If, however, Buyer requests for puppy to remain with breeder beyond 8 weeks, for whatever reason, Seller does allow a 2 week grace period for families to arrange a pick up/flight time beyond 8 weeks that works for everyone. In this case, once puppy turns 10 weeks old, the extended care boarding fee will then be applied at \$50 per day, plus the cost of any vet visits necessary during that time. Please note: the grace period option does depend on the breeder's timeline and personal schedule. There are times when the breeder's schedule may not permit the 2 week grace period, so it is important to discuss this matter in advance.

**\*\*Please Note: Payment must be made in full, including any boarding fee charges, by the time the puppy is 6 weeks of age, regardless of the scheduled pickup date.**

As a responsible breeder, our puppies are sold with limited AKC registration, meaning he or she may not be used for breeding and must be spayed or neutered at the appropriate age. Please refer to your veterinarian and send Seller evidence of spay completed within the next 8 months for a female or 12 months for a male.

In order to qualify for this guarantee, Buyer must provide written documentation from a licensed veterinarian of all vaccinations. These vaccinations must include Canine Distemper, Adenovirus Type 2, Parainfluenza, and Parvo MLV. Please note: Reactions to Leptospira Bacterin vaccines have been known to harm small breeds. We caution against it and will not be responsible for reactions to it, nor reactions to any other vaccine. To qualify for this guarantee, Buyer must have this puppy examined by a licensed veterinarian within 72 hours of the purchase date above. If Buyer fails to have the puppy examined by a licensed veterinarian within 72 hours of the purchase date listed on this agreement, Buyer forfeits any and all guarantees listed therein. In the unlikely event that, during this first vet examination, your pup is found to be in poor genetic health, Buyer may return the pup, accompanied by a written veterinarian statement of diagnosis and prognosis, within 7 days from the purchase date above, for a FULL REFUND of the purchase price. Buyer is responsible for all costs associated with the veterinary exam and transportation costs

related to the pup's return and the puppy is to be returned with all associated documentation, vaccination and veterinary records, AKC registration papers, etc.

This puppy has received loving, proper and nurturing care. To the best of Breeder's knowledge, this puppy is in good health at the time of sale, and the puppy has been given all vaccinations listed on the record provided to the Buyer. The Buyer is responsible for all further vaccinations and wormings from the date of sale/after 8 weeks of age. All pups have been examined by a licensed veterinarian prior to going home with their new families. All pups have been examined by a licensed veterinarian prior to going home with their new families. Seller does not guarantee against common, and easily treated illnesses, that may have been contracted after leaving the breeder's care, or by neglect of the buyer. Seller shall not be responsible for factors beyond their control including, but not limited to, the following: accidental death, sickness, poisoning, negligence, cruelty, return expenses, accidental injury, parasites, exposure to disease carrying animals, stress as a result of diet or environment, retained baby teeth, or cosmetic issues. While we can estimate, adult size, conformation, color, temperament, and coat type cannot be guaranteed.

If Buyer cannot care for, or keep this puppy, Buyer may return him/her with all veterinary records and registration papers. In this case, no refund will be given. In the event that Breeder has puppies in the home, and cannot safely accommodate at that time, every effort will be made to assist in finding another loving home.

Should a veterinarian find a life threatening hereditary or congenital disorder within 2 years of purchase, you must supply to us, within 7 days of diagnosis, two veterinarian's written reports, on your veterinarian's stationary. We reserve the right to have any diagnosis verified by a veterinarian of our choice. Upon our veterinarian's findings and prognosis, your puppy may then be returned to us, at Buyer's expense, along with registration papers and written statements of symptoms, diagnosis and prognosis from the two licensed veterinarians. Seller will, at Sellers discretion, then replace the animal with an animal of like breed and value within 1 year from return date. This timeframe is necessary to allow us to schedule an opening. All vet bills incurred toward this diagnosis will be the responsibility of the Buyer. Failure to do the above will null and void any guarantee on the part of the Seller. Buyer understands that such replacement is only valid when death or health problems are attributed directly to a life threatening genetic disorder and not due to injury, contagious illness or buyer neglect. In the tragic event of the puppy's death, a necropsy must be performed, at the buyers expense, to determine the cause of death and must have been attributed solely to the diagnosed hereditary or congenital disorder. Buyer understands that all guarantees are invalid 2 years after birth and this warranty applies only to the original buyer.

Because it is important to us that you and your puppy be happy, after purchasing, Buyer is given a time frame of 1 full week to determine if this puppy will be a good fit for your family. In the unlikely event that Buyer needs to return the puppy, within the first 7 days, Buyer agrees to forfeit 1/2 the purchase price. This offer is applicable within the first week of ownership only and with all accompanying records and documents. It is the buyer's responsibility to return the puppy, along with registration papers and any veterinarian records, to the Seller.

Please remember that a puppy is a great responsibility. He or she will love you unconditionally and deserves the same in return. Please take great care of him or her. Show your puppy the love and attention that they need to thrive. If, at any time, you are not able to keep, or properly care for this pet, you may return him or her, accompanied by this

contract, all documentation, veterinary records, and their AKC registration. No refund will be given in this circumstance, but your havanese will always have a home.
